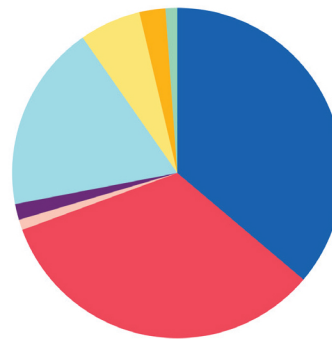
### SPECIAL NOTE TO OUR SUPPORTERS

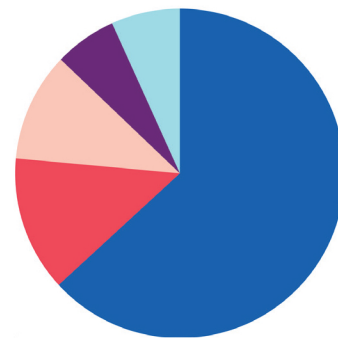

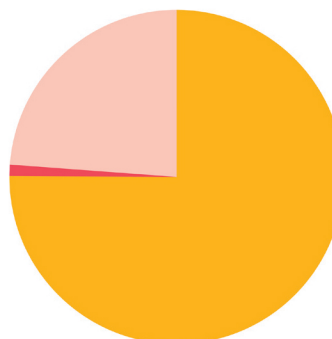

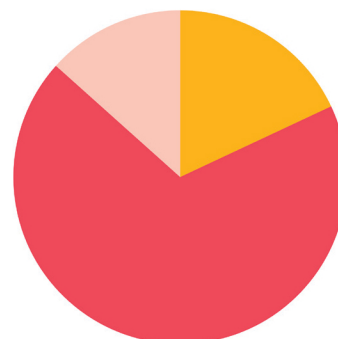
