# A. Facility Address & Information

The GEO-owned and operated Cheyenne Mountain Center is located in Colorado Springs, CO and strategically situated close to all necessary facility and detainee support services. This facility is an appropriately zoned, existing structure capable of providing secure residential, medical, and transportation services, as well as all support services necessary to meet the needs of adult ICE detainees (male and female) at multiple security levels, in compliance with ICE National Detention Standards (NDS) 2019.

### B. Facility Background


Originally opened in 2005, the Cheyenne Mountain Center is a 700-bed facility located in Colorado Springs, CO. Originally designed as a reentry center, the facility is well-equipped to be repurposed as an immigration processing center to support U.S. Immigration and Customs Enforcement (ICE) operations. The center's infrastructure already includes secure housing, administrative offices, and program spaces that can be adapted to accommodate individuals detained by ICE. The facility most recently served as a residential reentry facility for the State of Colorado until March 2020 and is well-suited to operate as an Annex to the Aurora ICE Processing Center.



# C. Facility Description

The existing facility can accommodate up to 700 ICE detainees, including the provision of security, health care services, food service, laundry, utilities, administrative support services, and transportation consistent with ICE's requirements.

# **Cheyenne Mountain Center Layout**



**Center Design:** The facility is made up of two buildings and sits on 2.83 acres. The main physical structure has three floors plus a basement and has 125,000 square feet of operational space. A smaller building serves as a facility armory and lock shop.

The basement level consists of the Medical Department, Food Service, Multipurpose Hall, Commissary, Barber Shop, Gymnasium, Laundry, Mailroom, Maintenance, Intake, Restricted Housing Unit (RHU), Shift Supervisor Office, Chaplain, and Programs Areas.

The first floor consists of Administration, Lobby, Master Control, Roll Call, Visitation, Library / Law library, and a Programs Room.



**Housing Units:** The facility has a design capacity of 700 general population and 48 Restricted Housing beds.

General Population Housing includes the following:

- Level 1 consists of 6- and 8-person rooms
- Levels 2 and 3 consist of 8- and 12-person rooms

The second and third floor have 14 rooms per side with two sides on each level for a total of 28 rooms on each floor. As there are no intake beds, staging can be performed in unused portions of the segregation unit and the indoor gym.

Medical Area: The Center's medical unit is equipped to provide on-site, primary care, mental health and emergency health care including lab, portable X-ray, and medication delivery. GEO will maintain active contracts with laboratories and other ancillary services required to provide comprehensive and medically necessary care. Medical equipment will include telemedicine and radiology capabilities to enhance care provided to the patient population.

The Center's medical unit includes the following:

- Patient waiting area (capacity of 15)
- Two medical beds
- Secured nurses station with two separate, controlled points of entry into the medical areas
- Four medical examination and treatment rooms, including a comprehensive medical triage/vitals room, and procedural/urgent care room
- Laboratory
- Corridor contains a patient bathroom, dental suite, medical records office, ample office space for medical /mental health personnel, staff restrooms, conference room, and staff break room
- Nurses station is adjoined to the secured pharmacy room with a pill line window attached
- Suicide watch room

**Visitation:** Visitation includes an open room located on the first floor with a capacity of 100. GEO proposes adding video teleconferencing booths to satisfy this requirement.



**Recreation:** The Center has one secure 16,600-square-foot outdoor recreation area equipped with 3 basketball courts and an exercise area. The Center also has a 2,109-square-foot indoor recreation area that includes a basketball court and separate 336-square-foot weight room.

Administrative Space and Parking: Administrative office space within the existing facility is limited. Specific ICE Administrative Office Space needs have not been identified. As such, GEO will negotiate with ICE on its office needs following contract award. The site has 79 parking spaces, 20 of which GEO can allocate for ICE use.

### D. Schedule of Availability

The Center can be available for intake of ICE detainees within 30 days of funding approval and dependent on the ICE background clearance process.

### E. ICE National Detention Standards (NDS)

As currently configured, the facility can provide all services in compliance with ICE's National Detention Standards – 2019 (NDS). The facility could be modified to meet ICE's Performance-based National Detention Standards 2011. We note, however, as this is an existing facility, there may be some standards that would require an exception.

# F. Quality Control Plan

GEO's Quality Control Plan dictates that all major functional areas of the Center be audited quarterly by the corporate Contract Compliance (CC) Division and by facility staff. These audits will be dedicated to ensuring all GEO internal policies and the client required standards are met. Following an initial pre-operational audit, an annual corporate audit reviewing the full scope of services will be conducted by a team of auditors chaired by CC. A second-tier review, the GEO facility internal audits, is conducted by the facility's subject matter experts using pre-identified GEO and client audit tools, with monthly audits targeting all functional areas on a rotating basis throughout the calendar year.

### III. Facility Services

### A. Management and Operations

GEO will provide a full staff of highly qualified, trained, and experienced personnel to perform the requirements of any subsequent RFP and contract. Our management team is committed and accountable to the achievement of high performance and customer satisfaction during daily operations. Our processes, procedures, post orders, and systems are mature, in place, in use, and well documented.



They will be supported by GEO's Western Regional Office located in Culver City, California, led by Regional Vice President (b)(6),(b)(7)(C) In addition, Corporate Headquarters support staff ensure that all necessary resources are available for successful performance.

Key management staff will assist the Facility Administrator in his or her endeavors to successfully manage and operate the facility on a daily basis and throughout the contract period of performance. A cadre of highly competent supervisors and professional practitioners will support the key management staff and provide day-to-day guidance and instruction to the facility's workforce.


### B. Transportation

### VI. Additional Information and Recommendations

# A. Current Services Provided to Federal Agencies

GEO is the largest secure support services provider to the U.S. Federal Government and the largest detention services operator for ICE. GEO also provides detention, transportation, and support services for the U.S. Marshals Service (USMS) and for Customs and Border Protection (CBP). GEO has a 38-year relationship with ICE dating back to December 2, 1986, with a contract award from the U.S. Immigration and Naturalization Service (INS) to provide a facility for secure residential care of undocumented aliens in Aurora, CO.

We presently have 18 facilities under contract to provide services to ICE.

### B. Proposed Pricing Structures

GEO recommends a two-part pricing structure, which is fair and equitable to both the Government and to the contractor. Our model includes a fixed monthly Facility Operations Charge (FOC) that covers all the direct, fixed expenses such as building depreciation, cost of capital, staffing, maintenance, utilities, etc. GEO also has developed an incremental per diem based on the level of occupancy at the facility which includes detainee food, medical, hygiene, clothing, etc. In this methodology, the Government does not pay variable costs for "empty beds." The contractor's direct expenses are totally covered at all levels of occupancy. This model is in use at locations in Florida, California, Colorado, and Pennsylvania.

### C. Recommended Changes to ICE Requirements

GEO believes the ability to better leverage technology can improve staff efficiency in our detention facilities. We recommend enhanced use of Telemedicine and Teleradiology in providing direct access for medical and psychological services to the detainee population, improving the quality of services and controlling certain costs. This modality for providing direct patient care can often decrease travel time and distances and increase timely access to sub-specialists in areas that are underserved.

# D. Potential Hiring/Staffing Challenges

While GEO recognizes that ICE works diligently on all background investigations, we are concerned with the length of time fitness determinations may take. As the current owner and previous operator of the facility, GEO understands the local job market and has the experience, resources, and capabilities to find and hire the appropriate staff. Hiring qualified staff and keeping them engaged during the lengthy background clearance process presents a challenge.

GEO can perform and certify the same background clearances (with the exception of the field investigation) to assist ICE in expediting the clearance process. GEO's current background screening process is very similar to the federal candidate screening process. Further, GEO's contracts provide ICE with 100% legal indemnification for all contract services provided by GEO employees.

### E. Potential Impediments to Facility Operation

The GEO-owned and operated Cheyenne Mountain Center is fully equipped, maintained, and appropriately zoned. We are not aware of any specific legal issues, discrepancies with statutes, or current political concerns.



Hudson is located just northeast of Denver on I-76, approximately 25 miles north of Denver International Airport and within a 2-hour drive of the following ICE offices:

### Facility Background

Hudson was built in 2009 and it has been without prisoners since 2014. It has been very well maintained, and its current condition reflects its low mileage. Hudson is available to be 100% dedicated as an ICE facility. Hudson has the flexibility to manage a wide range of offenders of different classification levels. With four distinct housing units, Hudson's design plan can simultaneously accommodate different detainee groups, including both male and female detainees, after some minor modifications to the fencing. Hudson is also expansion-ready: oversized dayrooms could easily accommodate additional bunking and in the longer term, Hudson owns 37 acres adjacent to the facility and already received a conditional use permit for a 1,000-bed expansion on that site.

Hudson has a 124-bed segregated housing unit (with 62 cells) for high-level offenders but there are many non-punitive areas suitable for lower-level detention. Hudson has massive dayrooms with washer/dryer hookups, wiring for televisions and phones, and coaxial cables in each cell. For recreation, each housing unit has a private recreation yard and Hudson also boasts a soccer field, a baseball diamond, a volleyball court, outdoor handball courts, an indoor handball court and a full indoor basketball court. Hudson also has a running track, a large garden space and nearly 12,000 square feet of classroom and education space.

### Ownership and Private Operators

Hudson has the infrastructure to house ICE non-citizens in a safe and secure environment. Hudson is owned by Highlands REIT, Inc. ("Highlands"), a public reporting real estate investment trust. Highlands is not an operator of correctional or detention facilities. Highlands was formed to work out non-core assets from our former parent company, which is how Highlands acquired Hudson.

Highlands has held advanced discussions with numerous potential operators for Hudson. Presently, such operators are conducting extensive due diligence on Hudson, including numerous site visits by contractors and specialists in the last month. Certain operators have already started working on facility activation plans for Hudson. Private operators want to be certain of ICE's selection of Hudson prior to committing to operation. Should ICE choose to utilize Hudson as a detention facility, an operator could take over Hudson practically immediately. Hudson's close proximity to Denver would make for a speedy facility activation. We estimate that depending on urgency and the specifics of the detainee population, Hudson could accept detainees in a matter of months. In short order, ICE's private operators could implement detention standards at Hudson that are acceptable to ICE.



#### SITE SUITABILITY – AURORA, CO

The Atlanta metropolitan area has the 24<sup>th</sup> largest immigrant population in the country—approximately 0.78 million individuals as of November 2024. We selected a location located in Aurora, Colorado, which is a short 22 miles to downtown Denver, and is a one and half hour drive to Cheyenne, WY (**Figure 2-1**).




Figure 3-2 Overview of building and interior office space



## **Medical Care & Treatment**

The detention facility will include a state-of-the-art medical infirmary. This space will ensure detainees have access to comprehensive and timely healthcare services. The facility will include (b)(4) to accommodate individuals requiring medical observation, treatment, or short-term inpatient care (<24 Hours). To support a range of medical needs, the infirmary will feature individual examination rooms for medical screenings, evaluations, and minor procedures, ensuring privacy and efficiency in patient care. Additionally, designated isolation rooms will be available for detainees with contagious illnesses or special medical conditions, meeting all infection control requirements. The infirmary will be staffed by qualified medical personnel and equipped with essential diagnostic supplies, emergency response equipment, and pharmaceutical storage. A secure medical records area will ensure confidentiality and compliance with federal regulations. By integrating these key components, our infirmary will provide high-quality, accessible healthcare services in alignment with federal detention standards while prioritizing the well-being and safety of all detainees.






## Outdoor Recreation
