

# **Internship Announcement Legal Intern Summer 2026**

### **Summary of Position**

Law students interested in public interest work are encouraged to apply for a summer 2026 intern position with the ACLU of Colorado located in Denver. Students should expect to work full-time for 7-10 consecutive weeks over the course of the summer. Legal interns at the ACLU of Colorado will gain valuable experience working under the supervision of ACLU attorneys on the wide variety of civil liberties issues that comprise the ACLU's docket. ## **Primary Responsibilities**

Law students interning with the ACLU of Colorado participate in many aspects of litigation and legal advocacy including legal research, legal writing, interviewing witnesses, and conducting other factual and legal investigation. Interns also participate in meetings with staff and cocounsel discussing case selection and litigation strategy.

#### Qualifications

ACLU of Colorado prefers students who will have completed two years of law school, have a demonstrated interest in civil rights, civil liberties and social justice, and possess excellent writing, communication, and organizational skills. Exceptional first-year students are also encouraged to apply.

#### **Essential Position Functions**

The following activities are essential for success in this role:

- Ability to remain at workstation for long periods of time.
- Ability to work in office at least two days a week.
- Communicate with others effectively in verbal and written formats.
- Use a computer.
- Answer and make phone calls/text messages.
- Ability to travel between locations across the state of Colorado.

### **Hybrid Schedule**

ACLU of Colorado currently has a hybrid work model that requires staff to work in the office at least 2 days per week and staff may work remotely or in the office the other 3 days.

#### **Compensation**

ACLU of Colorado will compensate successful intern applicants at a rate of \$22/hour that will be paid over the course of the internship as wages, subject to withholding. Students are still encouraged to seek grants or fellowships from public interest fellowship funds through their law school or other funders. Arrangements can also be made with the student's law school for work/study stipends, depending on the availability of work study in conjunction with a paid internship.

**Application Instructions** Students interested in spending a summer working with the ACLU of Colorado Legal Department should submit a cover letter explaining their interest in the ACLU of Colorado, a résumé, list of three references, and short writing sample (5-10 pages).

Applications will be accepted on a rolling basis and reviewed until the positions are filled. Interested applicants are encouraged to submit their applications by Friday, December 5, 2025.
