NOTICE OF APPEAL AND DESIGNATION OF RECORD	

Description of Nature of Case and Disposition in Trial Court

NATURE OF CASE: In the underlying case, Mr. Tettamanti was charged with and convicted of a municipal ordinance violation in the Municipal Court for the Town of Silverthorne. The Municipal Court subsequently issued an order to show cause for contempt, and Mr. Tettamanti appeared before the court. The Municipal Court then stated that it was finding Mr. Tettamanti in direct contempt of court and sentenced him to 3 days in jail. The Municipal Court subsequently issued a written mittimus indicating that the 3 day jail sentence was a sentence for the underlying offense, for which Mr. Tettamanti had previously been sentenced. This is an appeal of the Municipal Court's order and sentence, whether construed as a finding of contempt and imposition of sentence for contempt, or as a resentencing on the underlying offense.

CHARGES FOR WHICH DEFENDANT WAS CONVICTED: Silverthorne Municipal Code § 2-2-6 Failure to Control Pet and/or contempt of court.

DATE JUDGMENT OF CONVICTION ENTERED: Date of original conviction is unclear from the records currently available to Mr. Tettamanti. The purported finding of contempt entered on October 15, 2025.

DATE SENTENCE IMPOSED: The sentence appealed was imposed on October 15, 2025.

SENTENCE: 3 days in the Summit County Detentions Center.

Jurisdiction

The Municipal Court for the Town of Silverthorne is a qualified municipal court of record as defined in C.R.S. § 13-10-102(3). *See* Silverthorne Charter, §§ 7.1.a, 7.2.a. Jurisdiction over this appeal is therefore proper in the District Court for Summit County. *See* C.R.S. § 13-10-116(2).

WHETHER APPEAL BOND GRANTED: N/A

Issued Proposed to Be Raised on Appeal

Issues on appeal may include, but are not limited to: whether an alleged violation of a prior sentence may be punished as contempt of court; whether the municipal court failed to properly advise Mr. Tettamanti of his rights when facing a contempt citation; whether the municipal court properly found Mr. Tettamanti in direct contempt of court; whether the municipal court acted unlawfully by resentencing Mr. Tettamanti for an offense for which he had previously been sentenced; and any other issue going to the validity of the judgment and sentence entered on October 15, 2025.
