#### BASIS OF CLAIM

On May 10, 2017, Longmont Police Department (LPD) officers, along with a K-9, searched the Claimants' apartments, among others, in the Suites, a housing complex operated by the Longmont Housing Authority (LHA). LHA management ordered the Claimants out of their homes, which LPD then searched without warrants, consent, or any other legal justification. The searches were purportedly done as part of routine LHA maintenance inspections, which have only ever been conducted by LHA staff. However, in this case, LHA invited LPD officers to search the Claimants' homes with K-9's. The Claimants were given no prior notice that LPD or K-9's would be present for the inspection or search their apartments. The LHA staff and LPD officers ignored the Claimants' presence during the encounters, even where a Claimant was loudly objecting to the search.

#### NAMES OF PUBLIC EMPLOYEES

At this time, the names of all the public employees that caused the Claimants' injuries are not known. They include, but are not limited to, the following employees of the Longmont Housing Authority, headquartered at 1228 Main Street, Longmont, CO 80501:<sup>1</sup>

- Krystal Winship Erazo
- Alma Collins
- Other LHA employees, whose current identities and addresses are unknown, who were involved in the searches of the Claimants' homes on May 10, 2017, and/or were responsible, directly or indirectly, for supervising and/or directing the activities of Mses. Erazo and Collins.

#### NATURE AND EXTENT OF INJURIES, DAMAGES, AND LOSSES

The full extent of damages sustained by the Claimants is not fully known at this time, but it includes the emotional distress and mental anguish, including violations of their privacy, safety, and security in their own homes, and trust in law enforcement, they have suffered as a

result of the unlawful searches. The Claimants may bring tort claims for, *inter alia*, invasion of privacy, trespass, and false arrest/imprisonment. Actual, compensatory, and punitive damages may be sought. Other damages may be sought as discovery and investigation proceeds in this matter.

#### MONETARY DAMAGES CLAIMED

The full extent of monetary damages has not yet been fully ascertained. The Claimants will seek the maximum amount of monetary damages permitted by law, and at this time it appears that the damages will likely exceed \$100,000.00 for each Claimant.
