This Committee is a sanctioned political activist group on the CU campus in Boulder and is housed in the University Memorial Building, 1st floor. According to Griffin this group is expressing hard feelings about being relegated to a smaller office than they feel their stature warrants and CUPD is trying to keep tabs on this organization due to this and the fact that they have expressed hostility toward US policy in El Salvadore in general and UN Ambassador Jean Kirkpatrick in particular. The upcoming Kirkpatrick visit to Denver and the Colorado School of Mines on 5-6 and 5-7-83 has aroused a great deal of interest among various law enforcement agencies and the State Department.
