(S) [redacted] stated that on 7/19/2000, a group of people were observed outside of the Lockheed Martin facility video taping the front and sides of the building. When [redacted] approached the group and asked them what they were doing, they refused to reply and continued video taping the facility. One of the group handed the [redacted] a business card with the name "Activist Media Project" on it. This group also has a web-site at www.RMPJC.org.

(S) [redacted] stated that he had gone to the web-site and learned that the same group has also video taped the Department of Energy facility located at Rocky Flats. Although [redacted] acknowledged that the video taping was done from a public street in front of the facility, he was concerned that this may be a
