American Civil Liberties Union of Colorado

The American Civil Liberties Union ("ACLU") of Colorado is a nonprofit and nonpartisan statewide organization based in Denver with over 10,000 members working together to defend, protect and extend the civil rights and civil liberties of all people in Colorado, through legislative advocacy, public education, and litigation. The ACLU of Colorado is an affiliate of the national ACLU, which has more than 500,000 members and supporters and handles nearly 6,000 court cases annually. The American Friends Service Committee ("AFSC"), headquartered in Philadelphia, Pennsylvania, is a nonprofit organization that carries out service, development, social justice, and peace programs throughout the world. Founded by Quakers in 1917, AFSC's work is based on the Quaker belief in the worth of every person and faith in the power of love to overcome violence and injustice. AFSC's mission and achievements won worldwide recognition in 1947 when it accepted the Nobel Peace Prize with the British Friends Service Council on behalf of all Quakers. During the Democratic National Convention, Mr. Sedney plans to organize a large public parade to demonstrate to delegates the degree of broad-based grass-roots support for Senator Obama. Mr. Sedney is a citizen volunteer acting upon his political urges to express himself freely on behalf of Senator Obama's campaign for President, and is not an employee of the Obama campaign.

CODEPINK

CODEPINK is a worldwide women-initiated grassroots peace and social justice movement founded in 2002 that works to end the war in Iraq, stop new wars, and redirect resources into healthcare, education and other life-affirming activities. CODEPINK calls for policies based on compassion, kindness and a commitment to international law. With an emphasis on joy and humor, CODEPINK women and men seek to activate, amplify and inspire a community of peacemakers through creative campaigns and a commitment to non-violence. CODEPINK is based in regional offices in New York City, Washington, D.C., Los Angeles, and San Francisco, and has over 250 active local groups around the country and the world, including a chapter in Denver, Colorado, and reaches 150,000 through its weekly email updates. Escuela Tlatelolco Centro De Estudios

Escuela Tlateloco Centro De Estudios ("Escuela Tlatelolco") is a community-based private school in Denver, Colorado, founded in the late 1960's to provide an alternative education for young Chicanos, Mexicanos and Raza Indigena. Since its initial beginnings, Escuela Tlatelolco has expanded to include comprehensive K-12 education, a dual-language preschool Montessori, adult continuing education, daycare, family service work, a health office, and indigenous music and dance education. In addition to these programs, Escuela Tlatelolco has long played an active and prominent role in Denver regarding issues affecting immigrant and indigenous communities. Recreate 68

Recreate 68 was formed in early 2007 by a group of Denver activists when it became apparent that the city would be selected to host the 2008 Democratic National Convention. Recreate 68 recognized that many groups and individuals, both local and national, would see the convention as a unique opportunity to present their views to the delegates and elected officials who would be attending the convention. Recreate 68 was formed as an umbrella organization to support the nonviolent participation of a broad range of groups in the marches, rallies and demonstrations that have been a feature of all past conventions, and that we consider as integral a part of the political process as the convention itself.
